POSITION OBJECTIVE & SUMMARY

Oversees the planning, implementation, and management of information systems and infrastructure while ensuring data security, privacy and compliance with government and industry regulations and standards.

ESSENTIAL FUNCTIONS & RESPONSIBILITIES

- Directly oversee operations in the day-to-day projects. Monitor system performance, manage system updates/patches, and implement and enforce IT policies and procedures.
- Lead teams to ensure reliability and security of the business operations.
- Implement strategies and decisions set forth from senior management. Responsible for executing plans and projects that align with the business.
- Optimizing resources to ensure the resources are allocated effectively to meet business technology goals.
- Vendor management: by selecting and evaluating vendors. Negotiating contracts and ensuring vendor performance meets expectations.

- Technical skills: Understanding of IT service management framework. Infrastructure and systems management.
- Strong concept of cybersecurity principles and best practices.
